
For applying follow under this process:

After project registration approval by higher authority, you will get a confirmation & Registration certificate in your e-mail.

Third stage for online registration: Thirdly after project registration approval by higher authority, you can apply for getting land/ space .

Employment Generation: Proposal for maximum employment generation will be given preference.

Value Addition: Industries, involving in multi-stages of processing will be given preference.

Workers/ Employees: knowledge based workers/ employees will be given preference.

Research and Development (R&D): Activities involved R&D will be given preference.

Infrastructure provision: Leasable plots/ land/ ready space will have access with roads, connected withelectricity, water, gas (on availability) distribution lines and be secured by dykes andembankment.

Developed land: Developed land means and include considerable level of land filling andadequate offsite infrastructures.

Incentives: Government of Bangladesh has declared packages of Incentive for the hi- tech park Developers and Unit Investors to augment investment in the hi- tech park of Bangladesh as follows:

Special Incentives for Investors

- 1. 10 years Exempted income Tax (100% for first 07 years) IT-ITES industry.
- 2. Duty free import of capital machinery
- 3. 03 years income Tax exemption for foreign experts.
- 4. 50% income Tax exempted for profit

5.100% profit repatriation and 100% ownership for foreign investor.

- 6. Hi-Tech park will be treated as a bonded ware house.
- 7. Duty free import of construction materials.
- 8. Tax exempted up to 2024 for IT/ITES export income.
- 9. Exempted stamp duty for lease of any land or space.
